A blank cartridge will be fired in all stakes except the Open Puppy stake.

Horseback handling will be permitted in all stakes.

No handler horses will be provided.

Shotguns are not permitted on the grounds.

**DIRECTIONS TO GROUNDS:** LBJ National Grasslands - Decatur, Texas. From Hwy 380 in Decatur, go north on Hwy 730 for 9 miles. Turn left (west) at the cemetery sign onto CR 2461 then bear to the right onto CR 2560. Travel westerly for approximately 5 miles to CR 2675 which is gravel and turn right (northerly). Travel approximately 1.5 miles and turn right (east) on CR 2777. Camp area and starting point will be a short distance down the gravel road, is on the south side, and easily visible from the road.
